



Kingston Carers' Network is a registered charity, established in 1994, providing independent information, support and advocacy to people who care for someone living in the Royal Borough of Kingston upon Thames.

A carer is someone who looks after a family member, friend or partner who could not manage without their support. This might be due to a physical or mental health condition, addiction, or substance misuse. Carers are of all ages, and their caring responsibilities can put them under physical, emotional, and because they are unpaid, financial pressure. In the case of children caring for a parent or sibling, this can have significant negative effects on their lives and future opportunities. It impacts their learning and the social activities that their peers get to experience and enjoy.

At Kingston Carers' Network we aim to:

- Provide independent information to carers, whether they chose to continue to care, or to give up their caring role.
- Provide advice and support to individual carers.
- Ensure that the role and expertise of carers is understood, appreciated, and valued locally.
- Provide input into local service planning and ensure that appropriate services are available to carers.
- Promote carer involvement in service planning, ensuring their voices and opinions are heard and valued.
- Ensure that carers are aware of their rights and entitlements.
- Reduce social isolation and exclusion of carers supporting someone living in the borough.

Report of the Trustees for the Year Ended 31 March 2023

The Trustees (who are also directors of the company limited by guarantee for the purposes of the Companies Act 2006) are pleased to present their annual Trustee Report, together with the examined financial statements for the year ending 31 March 2022, which are also prepared to meet the requirements for a Directors' Report and Accounts for Companies Act purposes.

Structure, Governance and Management

Kingston Carers' Network is a charity registered in England and Wales with the Registered Number 1151456. The charity is a company limited by guarantee and was incorporated on 25 January 2013 and operates in accordance with its written Memorandum and Articles of Association. New Trustees are appointed in accordance with its Articles of Association.

Objectives and Activities

Purpose

The purpose of Kingston Carers' Network is to provide information, support, and advice to carers of people living in the Royal Borough of Kingston who could not manage without their support. This might be due to a physical or mental health condition, addiction, or substance misuse. As such, the charity is a public benefit entity and the trustees have had regard to the Charity Commission's guidance of public benefit.

Target Group – Definition

A carer is someone of any age who provides unpaid support to a family member, friend or partner who could not otherwise manage. This might be due to a physical or mental health condition, addiction, or substance misuse. A carer may also be juggling paid work with their unpaid caring responsibilities at home.

Anyone can become a carer; carers come from all walks of life, all cultures and can be of any age, including children.

The 2021 Census indicated that there are 12,101 adult carers supporting someone in the borough of Kingston.

Activities

The charity provides a comprehensive and holistic range of services, and this has developed in consultation with carers and other stakeholders. We have adopted the five outcomes pledged by the Government in the National Carers' Strategy:

- Not financially disadvantaged
- Mentally and physically well; treated with dignity
- Recognised and supported as an expert partner
- Enjoying a life outside caring
- Children thriving, protected from inappropriate caring roles.

Our current services adapted during the pandemic to include virtual support and have continued throughout the challenging circumstances of this period. They include:

- Independent information, advice, and advocacy.
- Specialist mental health and substance misuse carers' service.
- Young Carers' Project.
- Targeted Support Project
- Young Adult Carers' Project
- Out-of-hours advice service.
- Help with benefits, grants, and allowances.
- Signposting and referral to other services.
- Emotional support.
- Counselling.
- Outings and social activities.
- Programme of health and wellbeing activities.
- Complementary therapies.
- Support groups.
- Training and information sessions.
- Carers' Assessments carried out on behalf of Kingston's Adult Social Care.

Achievements and Performance

Adult Carers

This year we have supported over 4,513 carers across all our services. We saw a total of 1,049 adult carer referrals to our Advice Service. A key outcome of our advice service is to reduce the financial hardship of carers. This year we secured an additional £582,371 of new income for Kingston's carers and families.

Other key outcomes for adult carers included:

- 171 Carers' Assessments and Annual Reviews were carried out by the Adult Carers' Advice team on behalf of the Royal Borough of Kingston.
- 1,776 attendances at our carers' social and wellbeing events. These included fitness classes, poetry readings at the Rose Theatre and a residential trip.
- 56 peer support groups and lunches were held for carers including: carers of adults with mental health problems; carers of people with dementia, carers of children with ADHD and carers of adults with Asperger's Syndrome.

Feedback from carers provides evidence that we are achieving our key objectives. This year:

81% of carers said they had an improved understanding of their rights.

79% of carers are now recognised as expert care partners.

92% of carers are now enjoying a life outside of caring.

92% of carers have improved mental and physical health.

Young Carers

There were 134 young carers referred to our Young Carers' Project, and we provided 2,609 respite breaks for 935 young and young adult carers aged 5-22 at 214 activities.

Some of our key achievements include:

- 2,609 individual respite breaks were provided.
- Two weekly sessions held for young carers aged 5-11.
- Weekly youth group for young carers aged 12-16
- One to one support sessions were held with young carers.
- Science project, Curiosity ran regular activities, supporting young carers aged 8-12
- Mental health and wellbeing support provided.
- Targeted support was provided to young carers and their families with complex needs.
- Young adult carers aged 16+ attended regular support sessions.
- Mentoring project provided one to one support to 16 young carers.
- School lunch clubs provided support in schools.
- Transition group for young carers moving to secondary school.
- Young carers and families were supported in multi-agency meetings.

Volunteering Project

This year, we were supported by 73 volunteers who contributed their time and skills in a variety of roles. Volunteers gave over 2,722 hours of their time, which represents a saving in staff costs of around £32,524.

The valuable contribution made by our volunteers enables us to expand the service we offer carers, and we could not function effectively without them. Highlights from our volunteering project include:

- Our activity volunteers spent 511 hours supporting young carers.
- Our adult activity volunteers gave 96 hours support.
- Our admin volunteers provided 494 hours of administrative support.
- Our mentoring volunteers provided 893 hours of support to young carers.
- Our team of student counsellors provided 360 counselling sessions to carers.
- Our telephone befrienders provided 2935 hours of one-to-one listening.

Financial Review

A much tougher economic environment has led to both increased demand for the services and support that Kingston Carers' Network offers, whilst also making funding much more challenging to source. We are grateful to the many individuals and groups who donate to KCN and offer their financial support through a variety of fundraising activities and regular contributions. In particular we would like to thank the various organisations and companies that supported our first YCP Conference during the year.

Our donors are invaluable and enable the charity to continue to meet the needs of carers. During the year we have had generous support from RBK, Achieving for Children, City Bridge, Wellcome Children in Need Curiosity Fund, the Henry Smith Charity, the Edward Gosling Trust, Trust for London, and the Community Fund. We have received many grants from The Carers' Trust to direct towards individual carer needs. We have also been working closely with the NHS to see where funding from this source can help meet common goals.

Grants from statutory and other funding bodies remain a critical source of income for us, and applying for grants and demonstrating that we are meeting grant conditions through delivering key support services are important to our continued work. We are looking for opportunities to expand our funding sources where possible and this will be a key focus for us in the coming year.

Chairman's Report for the year ended 31 March 2023

Kingston Carers' Network (A company limited by guarantee)

Statement of Trustees' Responsibilities

Kingston Carers' Network (KCN) is a Company Limited by Guarantee and, since its incorporation on 25th January 2013, the charitable company has been administered by its Board of Trustees, who are also Directors of KCN for the purposes of Company Law. As such, they are responsible for preparing the Trustees' Annual Report and the organisation's financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice.

Company Law requires the Trustees to prepare annual financial statements that provide a true and fair view of the charitable company's state of affairs, its incoming resources, and the application of those resources, including income and expenditure over the period. In preparing these financial statements, the Trustees are required to:

Select suitable accounting policies and apply them consistently;
Observe the methods and principles in the Charities SORP;
Make judgements and estimates that are reasonable and prudent;
State whether applicable UK Accounting Standards have been followed,
subject to any material departures disclosed and explained in the financial statements; and
Prepare the financial statements on a going-concern basis, unless it is inappropriate to presume that the charitable company will continue in
operation.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company, and which enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company, and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities. The Trustees are responsible for maintaining the integrity of the financial statements.

As stated below, KCN continues to seek additional Trustees, especially those who have relevant experience and skills that would benefit the organisation. Trustees are recruited based on their skills and experience. All new Trustees are taken through an induction procedure to ensure they understand their responsibilities and have sound knowledge of KCN's policies and procedures.

Overview of 22/23

2022/23 was a watershed year for KCN in several ways. For the first nine months, the spectre of tendering for the Royal Borough of Kingston funding to provide adult carers support hung over us. It was an arduous process, skilfully managed by CEO Diane White, with input from numerous staff members and Trustees. We submitted in November 2022 and then had the long wait until February to her about the decision. Fortunately, we were successful in winning the tender (Voluntary Community and Social Enterprise (VCSE) Sector Commissioning 2023 - Phase 1 Lot 3a - Adults Carer Support) and hence we were awarded £240,000p.a. for 3 years (with a further 2 years extension provisionally). Not only that, we were delighted with the feedback on our application and pleased to note our score of 86%. I cannot stress how hard Diane, in particular, worked on this application process and we (and Kingston's carers) are indebted to her. It was perhaps no surprise then to learn shortly after we received the news, of Diane's intention to stand down from the role CEO shortly afterwards- her work done in some ways and culminating with this magnificent achievement. We now enter of new phase in our history, with newly appointed CEO, Tony Bennett- of whom you will hear more about in due course.

In addition to this major funding bid, it was business as usual as far as our fundraising efforts have been concerned. We have been fortunate to have secured funding, large and small from a variety of sources including *Henry Smith Foundation*, *Trust for London, Co-op Money, Carers Trust, Kingston Nursing Association*, *Kingston Charitable Foundation, John Lewis, Robert Holmes Estate Agent, Mayoral Celebration Weekend funding, KVA Health Inequalities Fund*, plus 3 tranches of funding from the South-West London Integrated Care System to facilitate discharge from Kingston Hospital and funds for carers wellbeing and winter pressures. We are particularly pleased to have been able to strengthen our links to Kingston Hospital Foundation Trust and local GPs (with whom we partnered on a Carer Awareness Event at the United Reform Church in New Malden- run by Dr Nick Merrifield from the Holmwood Corner Surgery).

In addition to these successes, KCN was also awarded the "Trusted Charity Quality Mark" which is designed to help staff, volunteers and trustees get involved in assessing how well our organisation is doing. This was assessed externally, and we passed with flying colours.

All that said, by far the most important and enjoyable event of the year was the Young Carers' Conference held at Chessington World of Adventures back in February. The idea was to provide a platform for the young carers to voice their experiences, take part in focus groups and share their concerns and experiences with those present, including invited guests from the local school and business community. This was the first time we have held such a gathering and it was a tremendous success- but don't take my word for it. Here is a quote from one parent:

"I just wanted to drop you a quick message to say thank you very much for having us at the Young Carers Conference yesterday! My young carer was so excited about the event and held her laminated ticket as if it was the Golden Ticket to Charlie and the Chocolate Factory! She loved every minute of it, and we were blown away by the activities, the magician, the competition entries which actually made me feel quite

emotional, goodie bag and treats all around. My daughter was so happy and proud. I know she wanted to hide away during the playing of 'You Can Count on Me' but then proudly stood up to show she'd taken part, and when X started dancing, she sat there with open mouth saying, "I didn't know she could do that!". I left her after this initial hour but I'm sure the rest of the day remained eventful, and we all got to enjoy the animals in the park after. So, this is just to say a huge thank you and very well done from us. It must've been an incredibly time-consuming task putting this all together but from our point of view it was all very much worth it, and my young carer really felt very special and loved. Thank you so much!"

Also as part of the event was also held a creative competition on the theme of 'caring'. The winning entry was from Cayden (aged 5) who wrote a poem about caring for his dad.

My Daddy cannot see
So he can easily be stung by a bee
I like to help him do small things,
like stopping the bus and reading him the book Fing.
Even though being blind is not fair,
it makes me happy to show him that I care.
(Cayden Age 5)

The Carers' Trust were particularly impressed by the event and invited one of the young carers present to join them at the Houses of Parliament for *Young Carer Action Day* in March and having seen its impact are keen to roll out the model to other areas in the UK.

Finally, the Board would like to put on record its appreciation to Diane and the staff and volunteers for their outstanding, dedicated work over the last 12 months, and in particular to Diane for her 14 years of service to KCN- 4 years as CEO. We wish her all the best in her role as Mayor of the Royal Borough of Kingston upon Thames. However, Diane would be the first to say that the biggest thank you goes to the carers themselves who unfailingly continue to support the ones they love.

I report on the accounts of the company for the year ended 31st March 2023 which are set out on pages 14 to 23

NOTES TO THE ACCOUNTS FOR THE YEAR TO 31 MARCH 2023

1 Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

2 Financial reporting standard 102 - reduced disclosure exemptions

The charity has taken advantage of the following disclosure exemption in preparing these financial statements, as permitted by FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland':

- Preparation of a cash flow statement

3 Accounting Policies

a) Income

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the statement of financial activities when receivable. Grants where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant. Income received prior to the period the funding covers is deferred until the period starts.

Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included.

Gifts donated for resale are included as incoming resources within activities for generating funds when they are sold.

Grants, including grants for the purchase of fixed assets, are recognised in full in the statement of financial activities in the year in which they are receivable.

Income from investments is included in the year in which it is receivable.

b) Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management. They are split using the number of staff hours spent on the main projects.

Tony Woods, Chair of Kingston Carers' Network introduced himself and welcomed everyone to the AGM. Particular welcome was given to The Worshipful the Mayor of the Royal Borough of Kingston Upon Thames, Councillor Yogan Yoganathan.

The Chair thanked the Royal Borough of Kingston Upon Thames for their continued support over the last year.

The Chair also thanked guest speakers Rt Hon Sir Ed Davey MP and Debbie Hustings, NHS lead for carers.

The business of the AGM will be carried out towards the end of the meeting.

Apologies for Absence

Apologies were tendered by the Trustees and KCN members listed as above.

Poetry Reading by Carers: Jo Lambert, Patricia Maskell, Layla Brokenbrow

Last year, KCN took part in the HeArt of Care project, involving poetry workshops. Jo Lambert took part in a fantastic poetry reading at the Rose Theatre Café on Thursday 9th June reading some poetry written as part of the HeArt of Care workshops.

Jo spoke about KCN and being a mental health carer and the support KCN provided to her. Here carer experience was recognised, and non-judgmental support was offered. Jo realised that the words she was using to comfort her daughter sounded like poems and formed part of her recovery from the trauma of being a carer. Jo has produced two books of poetry – Stay and Alliance which are available from Denny's Books in Thames Ditton.

Jo stated that KCN "saved her life" with our recognition of Jo's role as a carer.

Jo and other carers then read three poems:

Survivor - Jo Lambert - Carer

Darkness and Light – Trish Maskell - Carer

Post Diagnosis – Layla Brokenbrow – KCN Wellbeing Coordinator, who is a parent carer to her son.

All three poems were very poignant and moving. Jo asked that if anyone would like to become involved, to please speak to Jo who has a small stand at the AGM.

A Young Carer's view by Zayna

There are over 4,000 carers registered with KCN, and approximately 800 are Young Carers.

Julie Parker, Targeted Support Worker introduced Zayna, a young carer who spoke about her experience as a young carer with KCN's Young Carers' Project.

Zayna has been with YCP a number of years and is now 16 years old. YCP has helped Zayna both inside and outside school. Zayna has been going to lunch club since she was 9 years old and goes to youth groups on Wednesday nights at Searchlight Community Centre. Zayna said it was great to be able to speak with other young carers and felt it was a really safe environment at school. Zayna has been nominated for the Jack Petchey Award, and the Rotary Award, which has helped her with her communication skills, giving her the confidence to stand up and speak to a roomful of people.

Guest Speaker – Rt Hon Sir Ed Davey

Sir Ed Davey MP is the member of parliament for the Royal Borough of Kingston and leader of the Liberal Democrat party.

Sir Ed thanked Zayna, the Board, staff and volunteers of KCN for being a precious organisation for people in borough.

Sir Ed recommended a book - Labours of Love: The Crisis of Care by Madeleine Bunting. The book looks at care from a human and political perspective, and Sir Ed read several passages from the book regarding the range of human relationships that care runs through.

Sir Ed has been a carer for his mother and grandmother most of his life and has a son who cannot walk or talk. He highlighted the three main areas related to carers:

- 1. The need for a fairer society
- 2. The reform of the health service
- 3. Gender equality

He spoke about the effect of caring on reduced income and poverty, and about the need for more rights for working carers to get more support from their employers. There are also many housing issues for carers, where there are no rights of tenancy after the death of parents after many years of caring for them, leaving some carers homeless. Many of these issues are not generally recognised.

Carers are also often forgotten about by health services, for example, carers had to campaign to get priority for Covid vaccines during the pandemic.

By taking carers into account during the discharge and package of care arrangements, the NHS could be saved millions of pounds.

Report by the Chair - Tony Woods

The Chair invited everyone to read at leisure the full Chairman's Report printed on page 10 of the Annual Report, regarding the Carers' Strategy for Kingston, and the commissioning of services for carers in the borough.

KCN are also forging closer ties with Kingston Hospital Foundation Trust and the South West London Integrated Care System-being involved with the Rt. Hon. Sir Ed Davey MP, in addressing the need to shorten length of stay in hospitals.

Tony thanked Thom Braun and Dawn Whitcombe for their huge input into the Carers Strategy and KCN's key messages. Thanks also to Bob Humphries and Peter Whatnall for their hard work on the accounts. Huge thanks to Viv Rowlands for his operational contributions to KCN – we have a great team.

Thank you to Sushila Abraham for her work as a Trustee while balancing her role as Mayor over the last year.

Thank you to our funders City Bridge Trust, Carers Trust, Garfield Weston, The Edward Gosling Foundation and the Henry Smith Charity. Thank you also to RBK for their huge contribution to KCN's funding.

Finally, thank you to the Board, Diane, David, and the whole KCN team for the amazing job they have all done this year, but most of all, thank you to all our volunteers and carers.

Chief Executive's Report - Diane White

2021/22 was another year of many challenges for KCN. See Annual Report for Diane White's full CEO Report. Key highlights included:

- 1,272 adult carers referred to KCN
- 133 young carers referred to YCP
- 207 carers assessments and annual reviews completed
- Income of £838k and 70% from non-statutory sources
- 1,753 carers attended virtual wellbeing events
- Volunteers contributed over 3,057 hours of their time
- Financial gain for carers of over £1million

It is estimated that carers save the health and care system £239 million per year in the Royal Borough of Kingston.

Guest Speaker - Debbie Hustings, NHS Lead for Carers

Debbie Hustings is the NHS England Carers Lead (London Region). Debbie gave a presentation on the Commitment to Carers Programme.

Debbie spoke about her experience of caring for various members of her family over the years.

The primary functions of the programme are working with partners and stakeholders:

- To support the London systems in delivering the Carers objectives as set down in the Long-Term Plan.
- To provide assurance that these objectives are being implemented to both the regional Nursing and Quality Team and to the national NHS England Commitment to Carers Team
- To support the development of NHS Carer friendly practice across the region.
- To support Carer friendly employment practice within the region.
- To jointly work towards on integrated approach to supporting carers.
- Help everyone on their carers journey wherever they currently are.

Debbie went on to explain Integrated Care Systems (ISCs) and the changes from London based Clinical Commissioning Groups to ISCs.

She went on to talk about the Carers and the Health and Care Act 2022:

- The Duty on NHS England to involve and consult carers.
- The Duty on Integrated Care Boards to consult carers around planning and commissioning and around services relating to the patient for prevention, treatment and diagnosis.
- The introduction of new powers for the Care Quality Commission to assess local authorities.

- S91. A new duty on NHS hospital trusts in England to ensure that unpaid carers are involved as soon as feasible when plans for the patient's discharge are being made.
- The amendment covers all carers of adults needing care and support following hospital discharge, including health care support. This means that young carers looking after adults are included. New statutory guidance was published 31st March 2022 and updated 1st July. A further update is due in October.

Finally, the next steps are to focus on:

- Carers and Hospital Discharge
- Carer Contingency Planning
- GP Carer Quality Marker
- Carer Health Inequalities

Remarks from the Worshipful the Mayor of the Royal Borough of Kingston upon Thames, Councillor Yogan Yoganathan

The Mayor's remarks were brought forward in the agenda due to time restraints.

The Chair introduced the Mayor, Councillor Yogan Yoganathan.

The Mayor welcomed everyone and thanked Debbie, Sir Ed and everyone present.

The Mayor stated that it had been a remarkable year for KCN, with amazing statistics including dealing with over 1,000 referrals for carers. KCN are doing an excellent job, and carers would not cope without the support of KCN. KCN also provides a great return on investment. KCN helped carers gain over £1million in benefits, carers payments and grants in addition to all the services it provides, which is a great achievement for KCN. The Mayor emphasised the need for continued funding for KCN in order to support carers in the borough in the following years.

The Mayor thanked everyone for their hospitality and to KCN for the invitation to the AGM.

The Chair thanked the Mayor for his attendance and the Council's continued support.

Minutes of the 2021 AGM

The minutes of the 2021 AGM were agreed as a true record.

Adoption of the Annual Accounts for 2020/21

The annual accounts were not formally presented at this meeting. The Chair invited everyone to read the full record of the Annual Accounts in the Annual Report, and to address any questions to the Treasurer, Peter Whatnall. The Chair thanked the Finance Team and the auditors for the tremendous amount of work put into producing the annual accounts.

Adoption of the accounts was proposed by Peter Whatnall and seconded by John Mays. The accounts were agreed and adopted by the Board.

Appointment of Independent Examiner

Nazir Mahmoud will continue as the Independent Examiner for the coming financial year.

Our accountants, Nasir Mahmoud FCA, have entered into a merger with another partnership, and will henceforth be operating under the title of KAMP Accountants. Proposed by Dawn Whitcombe and seconded by Bob Humphries. Agreed by all.

Election of Directors to the Board of Trustees and Officers of the Board 2021/22
